This study would not have been undertaken without the initial encouragement of Professor Owen Connellan, former Head of the School of Surveying at Kingston University, with whom I first collaborated to write a paper, with Professor Billy McCluskey, for the 1998 World Congress of Surveyors in Brighton on “The Surveyor’s Role in Land Value Taxation”.
